

DAY 1 SUNDAY, AUGUST 18

ANCHORAGE

We depart today on our flight to **Anchorage**, the largest city in Alaska. Upon arrival, we will transfer to the hotel and rest up for the start of our Alaskan adventure tomorrow.

Note: Flights will be confirmed no sooner than 9 months before departure.

DAY 2 MONDAY, AUGUST 19

SEWARD

(BD)

Following breakfast this morning, we will board our deluxe motorcoach for a brief **city tour of Anchorage** before our scenic transfer to the coastal community of Seward. En route, we will enjoy lunch on our own and visit the **Alaska Wildlife Conservation Center**. The center is a sanctuary for injured or orphaned animals that offers over 200 acres of spacious habitats for the animals to feel at home and display their natural wild behavior. Visitors may see brown bears cooling off in the water, a bull moose strutting, wood bison roaming the pastures, and more! We'll continue on to Seward to settle into our rooms aboard the Norwegian *Jewel* and explore our home for the next seven nights.

DAY 3 TUESDAY, AUGUST 20

CRUISE HUBBARD GLACIER

(BLD)

On our first full day of cruising, we get up close and personal with the gigantic **Hubbard Glacier**, which is North America's largest tidewater glacier. It is made of 1,350 square miles of beautiful blue ice and is one of the most active glaciers in Alaska.

DAY 4 WEDNESDAY, AUGUST 21

ICY STRAIT POINT

The **Icy Strait Point** experience combines authentic regional culture with incredible natural beauty. While in port, optional excursions include enjoying Tlingit dancing and art or getting closer than one could ever imagine to humpback whales and brown bears in the wild. Choose to work up a wilderness hunger and satisfy it with fresh Dungeness crab, or take a cruise from Icy Strait Point and enjoy Alaska's awe-inspiring scenery.





DAY 5 THURSDAY, AUGUST 22

JUNEAU

(BLD)

Juneau has been called “Alaska's peak experience” certainly due in part to its unparalleled glacier viewing from such places as Tracy Arm Fjord, the Juneau Icefields, and Glacier Bay National Park. Optional excursions in Juneau include kayaking up one of the area's many protected waterways, going flightseeing, touring the historic downtown, or trying one’s hand at panning for gold. The majestic Mendenhall Glacier lies 12 miles outside Juneau and can be experienced from both land and sea.

Cruise past Sawyer Glacier - enjoy the magnificence from the comfort of the ship and have your camera ready!

DAY 6 FRIDAY, AUGUST 23

SKAGWAY

(BLD)

In a single year, this remote town along the Inside Passage grew from a few tents to a city of 20,000 gold seekers. Today, travelers come in search of other riches – to experience yesteryear along Skagway's charming boardwalk lined with buildings that replicate those Gold Rush days.

DAY 7 SATURDAY, AUGUST 24

KETCHIKAN

(BLD)

Its Tlingit Indian name, Kach Khanna, means “spread wings of the eagle.” Chances are we'll see one of these magnificent birds perched atop a Sitka tree. Thanks to its abundant rainfall, **Ketchikan** is surrounded by some of the world's most lush wilderness.
